

RETIREMENT



Stephen E. “Steve” Curtin retired from the MD-DE-DC District now referred to as the MD-DE-DC Water Science Center (WSC) in August 2016. Steve served his entire 42-year career in the WSC, the first 30 plus years in the then Annapolis field office and the rest in the Baltimore office. Steve, a groundwater hydrologic technician, did the majority of his work in the multi-aquifer system of the coastal plain of southern Maryland. In the almost half century that Steve worked in southern Maryland, the area changed from mostly rural to much more suburban and urban. Along with that change,

came the need for various water-supply management agencies to have a more factual record of actual water levels in the Aquia, Magothy, Patuxent, Upper Patapsco and Lower Patapsco Aquifers, which make up the multi-layer groundwater system in the area. In addition to the ongoing development, the system was also stressed by major water withdrawals from three electric power plants. Steve did the planning and coordination and led the actual data collection of the twice-annual data trips for obtaining high and low water levels for each of the aquifers in the system for all of the years of the project. He did the contouring of the potentiometric surface for each aquifer map initially under the tutelage of the late Fred Mack, and later on his own. The compilations of these data, in easy to read map form, were a popular report for water-management officials and the public for many years. Steve was author or co-author on about 150 of these reports as well as some 40 annual data reports. He also was an author on at least two major compilations of water-level data for the area. Steve, many times, also served as the lead for borehole geophysical logging in the WSC. Working closely with the Maryland Geological Survey, he logged many deep bore holes, primarily from water wells, that provided hydrogeologic framework data for filling in important gaps in the hydrogeology of the system. Steve also mentored many groundwater hydrologists and technicians on data collection and analyses techniques. In his later years, Steve served as the administrator of the entire groundwater data base for the WSC and also played a large role in transforming the instrumentation of the WSC’s groundwater network to fit a real-time data transmission system. Steve’s knowledge of the southern Maryland groundwater system and his everyday versatility will be missed. Steve and his wife, Mary Dee (also a former USGS’er) and son, Spencer, reside in Crofton, MD.

Bob Cory writes: Just finished reading the latest newsletter, 26 letters and 14 obits! I just turned 90 on June 16th and got some good tips on writing my own obit. Reading the newsletter prompted me to phone Andy Anderson one of my buddies from my USGS WRD days. Andy called me back and we had a good chat. A few months ago I received a brief letter from Jon Nauman out of the blue. Andy had phoned him up in Alaska and that prompted him to get in touch with me. Jon was my assistant on my marine biological studies and became good friends with Andy and family. I was sort of sort of a Maverick as far as the WRD was concerned. Probably the first or close to the first Marine Biologist hired by the USGS. Walt Durum hired me in anticipation of trying to get a staff together to start a marine program. The money never came thru and as a result Luna Leopold trusted me to have a small budget to carry out some studies that I convinced him would be of interest to USGS. Long story short I had a good run of about 18 years from 1965 to 1983. By that time technology had advanced to the point where an accumulation of data was keeping me too close to the desk and office when my desire was to be out on the water. I took an early out at age 57 and have been drawing a good pension for more than 33 years. Hard for me to believe. Before retirement I had the good fortune to buy 15 acres of marginal farm land in Anne Arundel County, 4 miles north of where I now reside in Calvert City. It had 3 acres of pasture and 12 acres of woods. Each year I planted about ½ acre (500-600 trees) Christmas trees while 2 acres were cleared out of the woods, selling the firewood. At age 70 quit the bee inspecting because the bees were dying from 2 parasites and their associated diseases. At age 83 I reduced

my bee colonies to 6 in my back yard and at 80 had stopped planting Christmas trees. Believe it or not I sold trees for 20 years. Fifteen last year, 2015, where I let some of my old customers help themselves and pay whatever suited them. My wife Jan and I just celebrated our 68th year of marriage and without her none of the above would have been accomplished. Health wise I've been truly blessed. At age 77, the day of our 45th anniversary landed in the emergency room with a heart block. I'm convinced that my good friend of Ed Pluhowsky of USGS WRD died about the same time in his sleep of heart block. Am now on my 3rd pacemaker, and 3 days ago everything looked good and expected battery life is 9 ½ years. Thank you to the editorial staff for keeping the newsletter going all these years.

Ivan L. Burmeister, 90, longtime resident of Iowa City, died Thursday, October 6, 2016, at Oaknoll Retirement Residence. Ivan was born December 13, 1925, in Plattsmouth, NE, the son of Max and Wilhelmina (Dagendorfer) Burmeister. He graduated from Louisville High School in Nebraska with the class of 1943. He enlisted in the United States Navy serving aboard the U.S.S. Craven during WWII. After four years of service he earned his Civil Engineering degree from the University of Nebraska, Lincoln, NE. 

Eight months into retirement his family encouraged him to find work outside the home. This led him to employment at Perfection Honda in Rio Rancho. Todd loved traveling, biking, camping, photography, hot air ballooning, motorcycling, auto racing, and spending time with his family, including playing with his grandson. He was a Packers, a Broncos, and a Hawkeyes fan. He coached many children, including Garrett and Amanda, in both football and soccer. 
Stuart W. 'Stu' McKenzie, 77, passed away on September 15, 2016 in Oregon. Stu was born on October 12, 1938 in Ellensburg, WA in the Kittitas Valley and grew up on his father's farm near Grandview, WA. Stu met his wife Connie while he was in the Peace Corp. He received his BS degree from the University of Puget Sound, Tacoma, WA and his MS from the University of Delaware, Newark, DE. He spent one year in the Coast Guard Reserves, and was hired in the WRD District Office of Maryland, Delaware and District of Columbia as part of the investigative staff for which much of the work during that period was county ground water studies done in cooperation with the Maryland Geological Survey. Other studies Stu participated in during this time included water-quality reconnaissance of streams in

Delaware and of streams affected by mine drainage in western Maryland. In 1973 Stu transferred to the Oregon District to work in the Portland project office as part of the first ever nationally sponsored Water Quality Assessment in the Willamette River, headed by Dave Rickert. By 1980 Stu participated in a water quality study in the Bear Creek Basin, which helped Jackson County identify and locate sources of pollutions and make plans to alleviate the pollution. As the USGS WRD moved forward with proposal for the National Water Quality Assessment (NAWQA) Program, resistance outside the Bureau from the Environmental Protection Agency was apparent due to competition for funds. Stu had a profound respect for farming and nature since he had been raised on a farm and was the perfect choice of farmer's son and scientist. Stu along with several other key WRD members made multiple presentations of the proposed program to the National Academy of Sciences seeking their support. The proposed program was so well received that their work was fundamental in gaining both Departmental and Congressional support. The NAWQA pilot program began in 1986. Stu headed the Yakima River Basin NAWQA pilot study in Washington, with full-scale implementation of the NAWQA program in 1991. He was able to navigate some politically challenging trust areas with the local farmers, irrigation districts, soil conservation districts, and the Yakama Nation tribal sovereigns. Without his leadership, the pilot study would have had great difficulty in successfully launching. One publication deserves special recognition for its contributions to the successful funding of the program: Circular 1090, "Persistence of the DDT pesticide in the Yakima River Basin, Washington" by Joseph F. Rinella, Pixie A. Hamilton and Stuart W. McKenzie. It served as a model for future publications focused on communicating scientific information. Stu's name appears as author or co-author of 37 WRD, USGS publications. Throughout his career, Stu received numerous awards from the U.S. Geological Survey (USGS) and cooperating agencies including a Meritorious Service Award for his outstanding NAWQA work. Stu is remembered personally for his work ethic, honesty and integrity, and his love of brainstorming how to improve studies and overall water quality programs. Stu was an excellent scientist and a great mentor and supervisor. He was mentor and supervisor for such notables as Tim Miller, Frank Rinella, Joe Rinella, and Greg Fuhrer. He retired from the Oregon District in 1997 and moved to Auburn, WA. Stu is survived by his wife Connie, two daughters, Suzanne and Carrie, and eight grandchildren. Stu was preceded in death by his parents.

Joseph "Joe" P. Piro, 91, passed away August 2, 2016 in Denver, CO, surrounded by his loved ones. Joe was born on March 19, 1925 to Eugene and Isabella Piro. At the end of 1986, Joe worked as a Financial Administrative Specialist in WRD's Nuclear Hydrology Program in support of Department of Energy's (DOE's) Nuclear Waste Storage Investigation. From 1988 to 1990, Joe served as the Chief of Administrative Services Section, Office of the District Chief for the state of Colorado. 
